In view of the continuing Covid-19 pandemic, the Ministry of Corporate Affairs ("MCA") has vide its circular dated May 05, 2020 read with circulars dated April 08, 2020, April 13, 2020 and Circular no. 02/2021 dated January 13, 2021 (collectively referred to as "MCA Circulars") permitted the holding of the Annual General Meeting ("AGM") through VC / OAVM, without the physical presence of the Members at a common venue. In compliance with the provisions of the Companies Act, 2013 ("Act"), SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations") and MCA Circulars, the AGM of the Company is being held through VC / OAVM. The detailed procedure for participation in the meeting through VC / OAVM is as per note no. 12
- 2. Pursuant to MCA Circular No. 14/2020 dated April 08, 2020, the facility to appoint proxy to attend and cast vote for the members is not available for this AGM. However, the Body Corporates are entitled to appoint Authorized Representatives to attend the AGM through VC/ OAVM and participate thereat and cast their votes through e-voting.
- 3. The attendance of the members attending the AGM through VC / OAVM will be counted for the purpose of reckoning the quorum under Section 103 of the Companies Act, 2013.
- 4. Members of the Company under the category of Institutional Investors are encouraged to attend and vote at the AGM through VC / OAVM. Corporate members intending to authorize their representatives to participate and vote at the AGM are requested to send a duly certified copy of the board resolution authorizing their representatives to attend and vote on their behalf at the AGM.




- 8. Members desiring any information as regards the accounts are requested to write to the Company at an early date so as to enable the management to keep the information ready at the meeting.





Continuous telecast of serials for long duration is not an easy thing in the competitive world of Television. Yet, our member EDIT II followed up the example set by Neela Tele Films and Directors Kut Production who had reached the milestone of 3000 episodes last year. Our member Edit II- Mr. Sanjay Kohli and Mr. Binaifer Kohli completed

1500 episodes of their above serial. A plaque in appreciation and honour was presented to them. This was a glimmer hope in the otherwise chaotic situation in the pandemic.

#### **Hamari Bahu Silk**

The dispute of Hamari Bahu Silk which involved three Producers and the broadcaster Zee TV was of epic proportion. The issue arose during pandemic and had gathered lot of media attention in view of the threats of suicide by some crew. To avoid the controversy IFTPC stepped in *suo moto*. In all 34 zoom meetings and 5-7 physical meetings were held. After a hectic deliberations satisfactory arrangement was arrived at. The crew and vendors are now paid to their satisfaction.

India has become the latest country to join the Global Creative Alliance (GCA), a group made up of 22 film and TV trade associations from around the world.




The GCA (Global Creative Alliance) is now made up of 22 countries including the UK, Australia, Brazil, Canada, France, Germany, India, Singapore, South Korea and the USA, amongst others. The purpose of the GCA is to encourage more effective international collaboration between producers and increase opportunities for co-productions.

UK producers can benefit from Pact's involvement in the Alliance through a shared Production Platform established to facilitate co-productions, joint events held at various points throughout the year, and the sharing of useful production information relating to countries in the Alliance published via the Pact Growth Accelerator.

While signing the MOU JD Majethia asserted the role played by the IFTPC during the pandemic and emphasised that IFTPC with a new logo is moving ahead with a renewed vigour and new vision.
